The Appaloosa Halter Futurity

Summary of Program

Stallion Owners:

The program will be based upon Stallion Owners each year contributing \$2,500.00 to nominate their stallion to the futurity. Payments will be made in two installments of \$1,250.00 each, payable on February 1st and March 1st, with slots being filled on a first come first serve basis. Enrollment for the 2019 breeding season will result in the 2019 and 2020 foals being eligible to participate in the Futurity events.

An Additional 10 slots will be made available for an annual enrollment fee of \$3,500.00 for these 10 slots. Enrollment for the 2019 breeding season will result in the 2019 foals and 2020 foals being eligible to participate in the Futurity events. Payments will be made in two installments of \$1,750.00 each, payable on February 1st and March 1st with slots being filled on a first come first serve basis.

*****The 2020 payments for Stallion enrollment will be due December 15th 2019 and January 15th 2020*****

Nomination of Foals:

Only foals who both (i) are sired by a nominated Stallion; and (ii) pay a nominate fee, may participate in Futurity Classes. Mare owners may nominate their foals to participate in the Futurity as follows:

- Within 60 days of being born the nomination fee will be \$100.00, increasing by \$50.00 each 60 days thereafter, for a maximum nomination fee of \$500.00

Nomination of Yearlings:

Yearlings that were nominated in 2018 will pay regular nomination fees

- Yearlings should be nominated by July 01
- Yearling nomination fee will be \$200.00

Yearlings that **WERE NOT** nominated in 2018 will pay a late charge plus regular nomination fee.

- Yearlings should be nominated by July 01
- If your horse **was not** nominated in 2018 the fee will be \$500.00 (late fee) and regular nomination fee of \$200.00

Futurity Classes:

At the Appaloosa World Championship Show we will have the following classes the day prior to the start of the Appaloosa Halter Events. Each Class will have an entry fee of \$300.00 (Weanling Classes) and \$275.00 (Yearling Classes) The proposal is that all nominated foals will be eligible for the following classes:

Weanling Year:

- Non-Pro Weanling Fillies
- Non-Pro Weanling Colts & Geldings
- Open Weanling Fillies
- Open Colts & Geldings

Yearling Year:

- Non-Pro Yearling Fillies
- Non-Pro Colts & Geldings

****Note:** The winners of the Weanling classes are not eligible to participate as Yearlings**

Summary of Funds; Payouts from 2018

We gave out over \$100,000.00 in cash and prizes at The 2018 Appaloosa Halter Futurity!!!! This was the largest payout in Appaloosa History.

1. No mare (s) will be bred prior to February 1st of any year that Nominated Stallion is enrolled in The Appaloosa Halter Futurity program.
2. ApHC and AQHA Stallions are eligible for enrollment into The Appaloosa Halter Futurity program.
3. The enrollment fee for 2019 (For the original 20 slots) is \$2,500.00 which is payable as follows: (a) \$1,250.00 on or before February 1st; and (b) the balance of \$1,250.00 on or before March 1st. All payments are non-refundable and in the event the fees are not paid in full, all paid fees will be forfeited and the Stallion will not be enrolled in the Futurity program for 2019.
4. The enrollment fee for 2019 (For the next 10 slots) is \$3,500.00 which is payable as follows: (a) \$1,750.00 on or before February 1st; and (b) the balance of \$1,750.00 on or before March 1st.
5. For Stallions enrolled in 2019, the following foals, upon payment of the requisite nomination fee, shall be eligible to participate in The Appaloosa Halter Futurity: (a) foals born in calendar year 2019; and (b) foals born in calendar year 2020.
6. All correspondence from The Appaloosa Halter Futurity, including notifications, voting, and other information will be sent to the address on this enrollment form. It is the responsibility of the Stallion Owner to provide any updated contact information to The Appaloosa Halter Futurity.

Nominations are on a first come, first serve basis. Reserving a slot requires the delivery of this 2019 Enrollment Form and initial installment. Slots will be reserved in the order received and a slot will not be reserved if the 2019 Enrollment form is not accompanied by the initial payment of \$1,250.00 or \$1,750.00 which ever one applies.

Stallions who are enrolled will have the priority for the slot in the subsequent year, provided all fees are timely paid, otherwise the slot will again be available on a first come first serve basis in such subsequent year.
